**Special City Council Meeting Minutes**

**1. Call to Order**

Mayor Pro Tem Ransom called the meeting to order at 9:00 a.m. and noted for the record that Councilmembers Evans and Turner were present.

**2. Resolutions**

- A. Consideration and action on a resolution canvassing the results of the General Election and Special Election held on the 5th day of May 2018, for the purpose of electing Councilmembers to Places 5, 6, and 7 (Mayor) on the City Council; for the purpose of adopting or rejecting ten (10) proposed amendments to the Charter; tabulating the returns; and declaring the results of the election (*City Council*)

Councilmember Turner moved, Councilmember Evans seconded for the adoption of Resolution 18-33: **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GREENVILLE, TEXAS, CANVASSING THE RESULTS OF THE GENERAL ELECTION AND SPECIAL ELECTION HELD ON THE 5<sup>th</sup> DAY OF MAY 2018, FOR THE PURPOSE OF ELECTING COUNCILMEMBERS TO PLACES 5, 6, AND 7 (MAYOR) ON THE CITY COUNCIL OF GREENVILLE, TEXAS; FOR THE PURPOSE OF ADOPTING OR REJECTING TEN (10) PROPOSED AMENDMENTS TO THE CHARTER OF THE CITY, DETERMINING THE NUMBER OF VOTES CAST FOR AND AGAINST EACH SUCH AMENDMENT, DECLARING THAT EACH SUCH AMENDMENT RECEIVING A MAJORITY OF THE VOTES CAST SHALL BECOME A PART OF THE CITY CHARTER, DIRECTING THE MAYOR TO CERTIFY AN AUTHENTICATED COPY OF SAID AMENDMENTS AND THE APPROVAL THEREOF BY THE QUALIFIED VOTERS TO THE SECRETARY OF STATE OF THE STATE OF TEXAS, AND DIRECTING THE CITY SECRETARY TO RECORD SAID AMENDMENTS UPON AND IN THE OFFICIAL RECORDS OF THE CITY OF GREENVILLE, TEXAS; AND PROVIDING AN EFFECTIVE DATE.** Motion passed by unanimous vote of the City Council present.

There being no further business, the Special City Council meeting to canvass the results of the May 5, 2018, General and Special Election, adjourned at 9:02 a.m.
