### Special City Council Meeting Minutes

#### 1. Call to Order

Councilmember Atkins called the meeting to order at 9:00 a.m. and noted for the record that he and Councilmember Dean were present. Section 67.004(a) of the Texas Election Code establishes the quorum level required to canvass election results to be two members of the canvassing authority.

#### 2. Pledge of Allegiance

Councilmember Atkins led the Pledge of Allegiance.

#### 3. Resolutions

- A. Consideration and action on a resolution canvassing the results of the General Election and Special Elections held on the 3rd day of November 2020, for the purpose of electing a Councilmember to Place 3 on the City Council; for the purpose of adopting or rejecting two propositions; tabulating the returns; and declaring the results of the election (*City Council*)

Councilmember Dean moved, Councilmember Atkins seconded for the adoption of Resolution 20-82: **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GREENVILLE, TEXAS, CANVASSING THE RESULTS OF THE GENERAL ELECTION AND SPECIAL ELECTION HELD ON THE 3RD DAY OF NOVEMBER 3, FOR THE PURPOSE OF ELECTING A COUNCILMEMBER TO PLACE 3 ON THE CITY COUNCIL OF GREENVILLE, TEXAS; AND FOR THE PURPOSE OF ADOPTING OR REJECTING PROPOSITION A AND PROPOSITION B; DETERMINING THE NUMBER OF VOTES CAST FOR AND AGAINST EACH MATTER; AND DIRECTING THE CITY SECRETARY TO RECORD RESULTS UPON AND IN THE OFFICIAL ELECTION REGISTER OF THE CITY OF GREENVILLE, TEXAS; AND PROVIDING AN EFFECTIVE DATE.** Motion carried by unanimous vote.

- B. Consideration and action on a resolution of the City Council of the City of Greenville, Texas; canvassing the returns and declaring the results of a bond election held in the City of Greenville, Texas, on November 3, 2020 and providing an effective date (*City Council*)
