Special City Council Meeting Minutes

1. Call to Order

Mayor Dreiling called the meeting to order at 10:02 a.m. and noted for the record that Mayor Pro Tem Ransom and Councilmembers Atkins, Kruse, and Money were present. Also present was City Secretary Carole Kuykendall.

2. Pledge of Allegiance

Mayor Dreiling led the Pledge of Allegiance.

3. Resolutions

- A. Consideration and action on a resolution canvassing the results of the General Election and Special Election held on the 1st day of May 2021 for the purpose of electing a Councilmember to Place 1, Place 6, and Place 7 (Mayor) on the City Council; tabulating the returns; and declaring the results of the election (*City Council*)

There will be a run-off election for Place 1 between Brian Hudgeons (26.15%) and Terry Thomas (49.24%) as there must be a majority vote. Jerry Ransom (67.47%) is elected as Mayor and Kenneth Freeman (54.21%) is elected to Place 6,

Councilmember Kruse moved, Councilmember Money seconded for the adoption of Resolution 21-19: **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GREENVILLE, TEXAS, CANVASSING THE RESULTS OF THE GENERAL ELECTION AND SPECIAL ELECTION HELD ON THE FIRST DAY OF MAY, 2021, FOR THE PURPOSE OF ELECTING A COUNCILMEMBER TO PLACE 1, PLACE 6, AND PLACE 7 (MAYOR) ON THE CITY COUNCIL OF GREENVILLE, TEXAS; DETERMINING THE NUMBER OF VOTES CAST; AND DIRECTING THE CITY SECRETARY TO RECORD RESULTS UPON AND IN THE OFFICIAL ELECTION REGISTER OF THE CITY OF GREENVILLE, TEXAS; AND PROVIDING AN EFFECTIVE DATE.** Motion carried by unanimous vote of the City Council present.

- B. Consideration and action on a resolution of the City Council of the City of Greenville, Texas; canvassing the returns and declaring the results of a bond election held in the City of Greenville, Texas, on May 1st, 2021 and providing an effective date (*City Council*)

Bond election passed with 82.45% vote.

Mayor Pro Tem Ransom moved, Councilmember Atkins seconded for the adoption of Resolution 21-20: **A RESOLUTION CANVASSING RETURNS AND DECLARING THE RESULTS OF A BOND ELECTION HELD IN THE CITY OF GREENVILLE, TEXAS, ON MAY 1, 2021.** Motion carried by unanimous vote of the City Council present.

- C. Mayor Dreiling to issue order calling a runoff election to be held June 12, 2021, for the purpose of electing a Councilmember to Place 1 and confirming procedures for said election as outlined in Ordinance 21-021 with early dates of Tuesday June 1 through Tuesday June 8 (*Mayor Dreiling*)

Mayor Dreiling called for a runoff election for June 12.


4. Adjourn
