PART I – REQUIRED MATERIAL

****THE APPLICATION WILL NOT BE ACCEPTED IF THE REQUIRED MATERIALS ARE NOT PROVIDED****

- SUBMIT A SITE PLAN WITH THE FOLLOWING (**FREE-STANDING SIGNS ONLY**):
 1. THE LOCATION OF THE AFFECTED LOT, BUILDING(S), SIGN(S), EASEMENT(S), PROPERTY LINES;
 2. THE SCALE OF THE SITE PLAN;
 3. THE LOCATION OF ALL EXISTING SIGNS ON THE SITE INCLUDING SIZE AND HEIGHT;
 4. SHOW DISTANCE FROM PROPOSED SIGN TO ALL EASEMENTS AND RIGHTS-OF-WAY; AND
- SUBMIT A SCALED DRAWING OF THE PROPOSED SIGN OR SIGN REVISION, INCLUDING SIZE, HEIGHT, COPY, STRUCTURAL FOOTING DETAILS, METHOD OF ATTACHMENT AND ILLUMINATION (**FREE-STANDING SIGNS ONLY**);
- SHOW THE LOCATION OF AND DISTANCE TO SIGNS ON OTHER PROPERTIES FOR SIGN TYPES SUBJECT TO SPACING REQUIREMENTS (**BILLBOARDS ONLY**);
- PROVIDE PROOF OF COMPLIANCE WITH ADDITIONAL SIGN DESIGN STANDARDS AS DESCRIBED IN SECTION 5-4.6 OF THE *GREENVILLE ZONING ORDINANCE* (**DIGITAL BILLBOARDS, ELECTRONIC SIGNS, MULTI-TENANT SIGNS ONLY**);
- SUBMIT ELEVATION OF BUILDING WALL WITH THE LOCATION AND DIMENSIONS OF PROPOSED AND EXISTING SIGNS (**WALL-MOUNTED SIGNS ONLY**).
