Each food handler at your establishment must be certified by completing an approved Texas Department of State Health Services health and sanitation training. Documentation for each food handler is required to be on site for the Registered Sanitarian to verify during regularly scheduled inspections. The Food Manager for the establishment must register with the City of Greenville and the fee is \$20.00. Copy of certificate and picture ID must be presented at time of registration. I agree to comply with the city of Greenville health code and understand that failure to do so may result in suspension or revocation of the permit. I agree to permit unrestricted access to an authorized representative of the City of Greenville.*
